bout a year ago, I was in discernment about whether I would throw my hat into the ring to be considered for the CEO position here at Marillac St. Vincent. A significant moment along that journey was reading *Just Mercy* by Bryan Stevenson and subsequently hearing

him speak. What was, and remains most compelling to me about his message, was his encouragement to "be willing to put yourself in proximity to injustice." In my case, it pushed me to the corners of Jackson & Francisco and Webster & Halsted, where we strive to confront injustice by providing opportunities to people who desire a hand up, rather than a hand out, to rise above life's daily inequities.

My time here at MSV has been filled with many occasions where I find myself both humbled by, and grateful for, the overwhelming generosity of so many people. People who, like you, give so unselfishly of their time, talent, and treasure to help us make an impact on the people who come through our doors. I am fortunate to be in a position of leadership that allows me to see our mission's impact first hand. Take the story of Semaj, for example (see next page). She joined our Project Hope program as a 17-year-old teen who was 6 months pregnant without much support. Today, she is on track to finish her associates degree this August and just moved into her own apartment. I hope you will read more about the many ways your help has aided Semaj to take next steps toward stability and independence.

It is inspiring to see how the spirit moves people to ensure the lives of clients like Semaj are changed for the better. The pages that follow are filled with pictures, stories, and snippets of opportunities we have had to serve those who walked through our doors in the last two years. # New Beginning for Young Mother

'm pretty sure I was in denial. And when I found out, I was in shock; my family was in shock. I couldn't believe it, and honestly, I was just really worried and scared." After attending her senior prom and graduating from high school, Semaj Wise was 17 when she found out she was 6 months pregnant.

When teenagers like Semaj experience an unplanned pregnancy without proper support, the consequences for the health and well-being of mother and child can be grim. But Semaj found Project Hope, Marillac St. Vincent's landmark program for pregnant and parenting teens.

"It was like a second family when I came here. I had a Doula who would take me to doctors' appointments, explaining to me what all the papers and procedures meant, how my baby was developing inside me, what to eat, what exercises I should be doing to keep my body in shape for the baby, and all the changes that my body was going through."

For over 30 years, Project Hope has offered program participants like Semaj prenatal and parenting classes, home visiting, and doula birthing assistance. Every participant works with staff to develop an individualized birth plan, giving pregnant teens and young women a better sense of what to expect when they go into labor, questions to ask medical professionals, and a caregiver roadmap during the critical first few weeks that the baby is home with the mother.

With the addition of MSV's infant room in our Early Childhood Education Program, mothers now have another option for child care as early as 6 weeks after the baby is born, enabling them to finish school or go back to work after their pregnancy.

"My son Elijah is thriving in the program at Marillac. Samantha in the Family Support program helps me stay on track with my goals. The food pantry has been amazing, and I always have fresh food in the house. I was hired as a Youth Mentor in Hope Junior at Marillac. I was connected to education support resources at One Goal in Chicago, and I'm finishing my 2-year degree at Harold Washington in August before hopefully finishing my bachelor's at UIC. And Project Hope put me in touch with La Casa Norte and I just moved into my own apartment. I feel like everything is coming together, and Marillac has been there every step of the way."

With support from donors, volunteers, grantmakers, and community partners, Semaj turned stressful circumstances into a positive, hopeful future for her and her son Elijah. "I'm at a point now where I feel empowered to pass this on and help other people, and Marillac St. Vincent taught me that. It's a family here, and just like my family helped me, it's my turn to help the people that will come after me."

# Early Childhood Education (FY18)

#### **Birth to Three & Pre-Kindergarten**

We guide children toward a lifelong love of learning by providing them with an environment that fosters emotional, interpersonal, and cognitive development. Our play-based curriculum inspires each child's natural curiosity, starting as early as 6 weeks through age 5. The program is NAEYC accredited and included in the Excelerate Illinois Gold Circle of Quality.

The school age after-school and summer programs at MSV keep children safe and engaged in learning when they are not in school. Our programs provide opportunities to cultivate strengths, acquire new skills, and develop and expand critical thinking and problem-solving capacity. Youth participate in mentoring programs, life-skills training, athletics, violence prevention programs, tutoring, and academic support.

#### **Hope Junior**


MSV's neighborhood after-school, summer, and teen leadership program exposes children and youth on Chicago's West Side to a world of opportunities. Through art-making, volunteering, basketball, dance, robotics, drama, STEM programming, and countless other activities, Hope Junior is designed to excite and engage young people and foster strong connections in the community.

#### **Project Hope**

Project Hope is our West Side program for pregnant and/or parenting teens and young women. Through group support, home visits, dould birthing assistance, parent education, referrals to resources, and by providing material needs such as diapers and baby furniture, the program helps prepare young women to become great mothers.

Our Outreach Program is a key and comprehensive resource for vulnerable individuals and families. Through individualized support, access to on-site resources, and strengthening community connections, our participants receive tailored services to meet their specific needs to increase stability and self-sufficiency. We accomplish this through personalized case management, increasing access to food, utility and public benefit applications, and computer literacy education and access.

#### **Senior Services**

Senior Services programming helps vulnerable older adults successfully age in place. We address the effects of poverty and isolation for seniors facing economic instability, food insecurity, and with limited support systems. At-risk seniors are supported by comprehensive, intensive case management, well-being checks, free grocery delivery, transportation, and public benefit applications. Active seniors participate in enrichment programs and social activities. Low-income seniors residing in nursing homes are provided with education about their right to live in the least restrictive environment.




#### **Fiscal Year 2017 Revenue**


#### Fiscal Year 2017 Expenses
